NASEMSO Goals

- + To promote the orderly development of coordinated EMS systems across the nation
- To promote uniformly high quality care of acutely ill and injured patients
- + To provide a forum for the the exchange of information and the discussion of common concerns among state EMS officials
- + To facilitate interstate cooperation in such areas as patient transfer, communications and reciprocity of EMS personnel
- + To disseminate pertinent information to our membership and others



NASEMSO Goals

- + To maintain ongoing and effective liaison with state and national governments, professional organizations, and other appropriate public and private entities
- + To improve the quality and efficiency of state EMS program administration
- + To enhance the professional knowledge, skill and abilities of state EMS officials and staff
- + To encourage research and evaluation in all areas of EMS
- + To serve as a permanent national advocacy group for the EMS



Benefits of NASEMSO

+ Representation:

The Association speaks on behalf of state EMS programs, and advocates to sustain strong EMS systems on a national level

+ Washington Update:

Monthly electronic newsletter with regulatory and legislative activities, national projects, and resource developments

+ Mini-Survey Service (for the state EMS Official only):

Quick turn-around data collection mechanism for the state EMS offices on specific questions



Benefits of NASEMSO

+ Mailing List

NASEMSO is the only source of a comprehensive listing of EMS agencies across the country.

+ Monographs

Periodic comprehensive data collection from state EMS offices determines how each state's programs compare in terms of structure, services and regulations. The documented results are very useful to anyone who is interested in national, state and local EMS policy development.

+ Website

A comprehensive source of infor themation and resources about NASEMSO activities, the website is continually updated with current and past projects and action by NASEMSO. The members-only section provides access to member lists and meeting records.

NASEMSO Councils

- + Each council is a working body of the association
- + Councils may present policy and position recommendations to the NASEMSO Board of Directors for the approval
- + External communications are the responsibility of the NASEMSO President and Board of Directors



NASEMSO Councils

- + Sharing of best practices
- + Developing and encouraging mentoring programs
- + Joint resolution of obstacles and challenges
- + Work on federally funded projects
- Nationwide promotion of evidence-based decision making for the EMS system development



Membership of Councils

- One member and one alternate from each state and territory as appointed by the State EMS Director
- + Where the function represented by the council is not fulfilled by an employee of the state EMS office, the state EMS director decides who represents the state as the voting representative to the council
