## ACEP SimBox

- SimBox contains a low-fidelity manikin that can be used to do simulation training in EDs and agencies on a more regular basis, as well as during the pandemic (continue education/training while limiting exposure and risk). The manikin is used in conjunction with free, online videos (You Tube), which include several case scenarios. The website is www.acepsim.com
- Review potential pediatric submissions for next year's annual conference and discuss the process for program building.

- Reviewed AHA Interim Guidance for Basic and Advanced Life Support in Children and Neonates With Suspected or Confirmed COVID-19
  - NAEMSP has endorsed the AHA Adult guidelines, and refrained from endorsing the Pediatric Guidelines, due to concerns raised by our committee and the board regarding early intubation, interruption of chest compressions and other aspects around PPE during resuscitation.

#### 2020 Goals Summary:

- Complete the 'Airway Management' and 'Medication Dosing Safety' NAEMSP Position Statements and their attendant resource documents. This will include peer review by the board and revisions, if the documents are felt to be acceptable or revisable.
- Consider a 'Reporting Child Abuse and Neglect' Position Statement and Resource document proposal, and/or a survey of relevant EMS protocols.
- Partner with the Rural EMS committee to promote pediatric rural EMS research and education.
- Explore adding more pediatric content to the Medical Directors course
- Expand pediatric educational resources on the committee website
- Continue to expand BaseCamp Communication
- Continue to build liaisons with other NAEMSP committees
