## **Regional Reports:**

• **Western Plains**: Jay Ostby (WY) – Seeking voluntary participation in a Ketamine reporting project and they're planning a meeting in the near future.

#### **Old Business**

- DMC Strategic Direction The board has not provided any guidance since our last meeting.
- NEMSIS "101" Document The TAC received great feedback on the last call, per Julianne, and is reworking the content for consideration.
- Extended Data Definitions The TAC is still accepting feedback for the document shared on Basecamp. There was lengthy discussion about using terminology friendly to non-EMS personnel (e.g. Patient versus Incident), documentation (and lack thereof) by non-transporting agencies.
- ET3 Update Eric Chaney shared that Yale's document did not make it through the review process in time for today's meeting.

### **New Business**

- ASTHO Post-Overdose Project Tim (NJ) and Rachel lead discussion on a new boardapproved ad-hoc committee. ASTHO is sponsoring some funds and is hosting a kickoff meeting in Atlanta on March 10-11.
- NEMSQA FAIR EMS Measurement Project Funded by a grant, Biospatial to add the measures. Joshua Sturms spoke about the attributes of the three year project.
- CSTE EMS Case Definition Advisory Council of State and Territorial Epidemilogists has
  extended an invitation to NASEMSO to participate in a new advisory group to develop a
  standard case definition for non-fatal opioid involved overdoes specifically using EMS data.

#### NHTSA Office of EMS

- RFP Update Eric stated they're in very early stages working on the RFP. A priority is
  development of a contract with the NEMSIS TAC to move the National Repository into a
  Federal cloud facility. More information is to come during the .org to .gov transition.

- State Training: Writing Efficient Business Rules, March 3, 2020 at 10 AM (MST) Julianne pointed out the access information for Joshua Legler's best practice session.
- 2019 Data Submission Deadline Monet thanked everyone who pushed through DEM and other submission issues to achieve the February 15 deadline. The warehouse will remain open a few more days for states that have extended collect timelines.
- Performance Measures Safety-01 and Safety-02 Josh updated the group and demonstrated recent changes to the performance measures dashboard. These are using the NEMSQA definitions.
- Schedule for the v3.4.0 Schematron Update Josh described the national schematron rewrite progress. Once the test phase is complete they will finalize rules by the end of March.
- NEMSIS Support Materials Page Monet guided the members to a group of non-technical resources, such as Harmonizing NEMSIS and CARES in v3.5.0, on the NEMSIS website.
- Travel Related Custom Elements Clay highlighted in the National Custom Element Library, searching for travel reveal those already incorporated by other states. There was interest in developing standard questions if not for the current hot topic communicable disease outbreak but one in the future.
