It started with a concern about the frequency of updates but then took an unexpected turn. Participants voiced concern that the States are collecting data but not sharing the outcome. Their ability to get data out is poor and despite trying to create a common dataset across all states, there is too much inconsistency between the states.

Steve McCoy was also present and attempted to explain how the data is being used nationally. How other groups such as CARES & Biospatial were also using this data. But this still didn't seem to answer their concerns. Discussion followed with several providing similar instances they had locally. When asked if there are others that also feel this way, what could be done to address their concerns? Suggestions centered around communications and funding.

Minnesota & Wisconsin were identified as the states this group was concerned were not sharing consistent data. It was decided this was a topic that needed further consideration but we had other agenda items that also needed to be addressed. It was decided everyone would consider ways to address this issue and the topic will be added to our next webinar for further discussion.
