 - Conference Call November 28, 2018
 - Federal Interagency Committee on EMS (FICEMS): Working with the FCC to support removing the second "9" when dialing "911" in commercial buildings.
 - National Highway Traffic Safety Administration (NHTSA) Office of EMS: Discussing final revisions to the EMS Agenda 2050
 - Department of Homeland Security (DHS): Discussion about "Office of Countering Weapons of Mass Destruction" (recently formed); "Human Trafficking" and "Stop the Bleed" will remain in this new office.
