In regards to NASEMSO, I'd really like to see if the QI monitor tools and resources that are being used by the PedsReady QI Collaborative can be released to states so that we can share those with our hospitals (after the collaborative is completed next year). I understand completely that these documents have needed to remain embargoed while the collaborative is in process. However, I thought that once the collaborative is completed next year, that the tools, etc would be distributed. I recently heard that nothing will be released until publications are written and published, which will minimally take a year (after the collaborative ends). So, it could be 2021 or later before these tools are released. I'm not sure how accurate this information is, but I think it might be helpful if we as NASEMSO PEC are able to advocate for the sharing of the tools once all the work of the collaborative is completed. These are really useful tools that can benefit a wider audience. Not sure what your thoughts are on this, or if you feel it would be a topic for discussion.
