Interim Final Rule on Maintaining Medicaid Enrollment During Public Health Emergency

Under the Families First Coronavirus Response Act, states receiving the temporary bump in Federal Medical Assistance Percentages (FMAP) were required to maintain enrollment and coverage for all beneficiaries through the end of the month in which the PHE for COVID-19 expires. Under the interim rule, to maintain the increased FMAP, states must maintain Medicaid enrollment of “validly enrolled beneficiaries” falling under one of three tiers of coverage. States may terminate enrollment for individuals not validly enrolled, after providing advance notice and fair hearing rights. States can also make changes to beneficiary coverage, cost-sharing and post-eligibility treatment of income. Read [more](#).

CDC Reevaluates Provisional Drug Overdose Death Counts

Recent improvements in timeliness and data quality have prompted a re-evaluation of the length of time that data quality requirements have had to be met for states to be included in data reported by National Center for Health Statistics (NCHS), National Vital Statistics System, 2016-2018. As a result of this re-evaluation, trends for additional states have been updated and more will be added as they meet data quality and timeliness requirements. Read more [here](#).

FEMA Announces Allocations for Feeding and Sheltering

The Federal Emergency Management Agency (FEMA) has announced the allocation of \$125 million authorized by Congress for FY 2020 based on criteria involving the latest national population, unemployment, and poverty data. The funds will be used to assist social service organizations dedicated to feeding, sheltering, and providing critical resources to our nation's hungry and homeless. EFSP funds are used to supplement food, shelter, rent, mortgage, and utility assistance programs for people with non-disaster related emergencies. Of this year's allocation, 8% will be made available to State Set-Aside Committees that will make funding determinations to aid people in jurisdictions with needs that may not be reflected in the National Board's qualifying formula.

USDOT Takes Next Steps on Drone Integration with State and Local Governments

The U.S. Department of Transportation announced it was formally concluding its three-year Unmanned Aircraft Systems (UAS) Integration Pilot Program. However, eight of the nine state, local and tribal governments that participated in the program have signed new agreements with the Federal Aviation Administration to continue to tackle remaining drone integration challenges as part of a new initiative called [BEYOND](#). The new initiative will answer ongoing issues surrounding the Beyond Visual Line of Sight operations that are repeatable, scalable and economically viable. Specific emphasis is placed on community engagement efforts to collect, analyze and address community concerns; infrastructure inspection, public operations and small package delivery; and leveraging industry operations to better analyze and quantify the societal and economic benefits of UAS operations. USDOJ Announces \$825,000 Penalty to Settle Helicopter Violations

United States Attorney Jason R. Dunn announced that Air Methods Corporation has agreed to pay \$825,000 to settle a civil case alleging that the company violated Federal Aviation Administration (“FAA”) regulations by operating an emergency-services helicopter with severely corroded pitot tubes. On November 4, 2019, the United States filed a civil action, *United States v. Air Methods Corp.*, 19-cv-03130-RM-NRN (D. Colo.), seeking to recover civil penalties from Air Methods. The United States contended that, by operating an air-ambulance helicopter with severely corroded pitot tubes, Air Methods violated FAA “airworthiness” regulations, which require aircraft to be in a condition for safe operation. Air Methods, headquartered in Greenwood Village, Colorado, is the country’s largest air medical transport services provider. The claims against Air Methods are allegations, and in agreeing to settle this matter, Air Methods did not admit to any liability. The [FirstNet Authority Roadmap](#) is designed to guide the growth, evolution, and advancement of FirstNet. Developed with input from public safety, industry, government, and our network contractor, AT&T, the Roadmap provides a view of public safety’s operational needs and technology trends for mobile broadband communications over the next five years. *The First Responder Network Authority recently hosted two Roadmap Update webinars with FirstNet Authority staff and leadership that outlined the data-driven approach to the Roadmap update and discuss updates to the Roadmap priorities.*

New GAO Report Highlights Broadband Shortfalls

The Federal Communications Commission’s (FCC) “high-cost program” is intended to promote broadband deployment in unserved areas. Millions of Americans do not have access to broadband. Within the Universal Service Fund, FCC’s high-cost program provided about \$5 billion in 2019 to telecommunications carriers to support broadband deployment in unserved areas where the cost to provide broadband service is high. In 2011, FCC established five performance goals and related measures for the high-cost program. The U.S. Government Accountability Office (GAO) was recently asked to review the high-cost program’s performance goals and measures. GAO is making four recommendations, including that FCC should ensure its high-cost program’s performance goals and measures align with leading practices and publicly report on progress measured toward the goals. CRS Highlights Mask Mandates in New Report

The Congressional Research Service (CRS) recently posted its recent “Legal Sidebar” report to Congress on legislative authorities to mandate the wearing of face masks. This Sidebar provides an overview of the relevant federal authority to issue such a mandate, as well as other legal considerations for Congress. (Federal authority to mandate mask wearing in more limited settings, such as within certain federal properties, is beyond the scope of the document). Zoom Adds New Security Features to Online Meetings

Zoom, the popular web conferencing platform, recently released new security features to remove and report disruptive meeting participants. Hosts and co-hosts can already report users from the Security icon, but now meeting participants can also report a disruptive user directly from the Zoom client by clicking the top-left Security badge. Suspend Participant Activities, lets hosts and co-hosts pause a meeting, remove an uninvited user and notify Zoom’s Trust and Safety team. After the host or co-host has reported the user, they can re-enable meeting features like video, audio, in-meeting chat or screen sharing, which are put on hold as they’re blocking the disruptor. In addition, Zoom has deployed an At-Risk Meeting Notifier to scan public social media posts and other websites for publicly shared Zoom Meeting links. When the tool detects a meeting that looks to be at high risk of being disrupted, it automatically alerts the account owner by email and provides advice on what to do. These steps could include deleting the vulnerable meeting and creating a new one with a new meeting ID, enabling security settings. If you do get an email, it’s critical to take action or risk having your meeting disrupted. As a reminder – one of the best ways to keep your Zoom meeting secure is to **never share your meeting ID or passcode** on any public forum, including social media. START Seeks to Collect Pandemic Effect Data on First Responder Communities Including EMS

The National Consortium for the Study of Terrorism and Responses to Terrorism—better known as START—is a university-based research and education center comprised of an international network of scholars committed to the scientific study of the causes and human consequences of terrorism in the United States and around the world. The ongoing COVID-19 pandemic has imposed costs on the country’s police, fire, and emergency medical services. First responders risk exposure in their jobs, yet must maintain operations in order to ensure the safety of the communities they serve. START seeks to collect data on COVID-19 impacts on first responder communities and provide evidence-based best practices. NCSL Reports Pandemic Appears to Exacerbate Risky Driving Behaviors

According to the National Conference of State Legislatures (NCSL), “The National Highway Traffic Safety Administration’s (NHTSA) early estimates of traffic fatalities for the first six months of 2020 indicate that the number of traffic deaths decreased 2% as compared to the same period in 2019. However, the fatality rate—number of fatalities per 100 million vehicle miles traveled—increased from 1.06 in the first half of 2019 to 1.25 in 2020. Excessive speeds and increased average speed but also lower seat belt use started appearing as possible culprits. Additionally, measures of cellphone motion—an indicator of smartphone distraction—increased roughly 15% between March and April 2020. These novel approaches to distracted driving data collection suggest that while mobile device use by drivers was already a concerning issue prior to COVID-19, ‘phone distraction per mile driven became even more frequent during the lockdown.’” Read more at <https://www.ncsl.org/blog/2020/11/19/covid-19-appears-to-exacerbate-risky-driving-behaviors.aspx>.

More Than 1M Children in U.S. Diagnosed with COVID-19

State-level reports are the best publicly available data on child COVID-19 cases in the United States. The American Academy of Pediatrics and the Children’s Hospital Association are collaborating to collect and share all publicly available data from states on child COVID-19 cases (definition of “child” case is based on varying age ranges reported across states; see report Appendix for details and links to all data sources). The number of new child COVID-19 cases reported this week, nearly 112,000, is by far the highest weekly increase since the pandemic began. At this time, it appears that severe illness due to COVID-19 is rare among children. However, there is an urgent need to collect more data on longer-term impacts on children, including ways the virus may harm the long-term physical health of infected children, as well as its emotional and mental health effects.

Fall Prevention Focus of New AHRQ Funded Study

Falls are the leading cause of preventable injury, and while many strategies have been developed to try to stop them and their resultant injuries, they remain a persistent problem. Research by Brigham and Women's Hospital has been driven by the question: Why, after more than 30 years of research, do patients continue to fall? The answers that the team uncovered resulted in the creation of a toolkit that includes low-tech solutions, such as a laminated poster to display by patients' beds, tailored prevention plans that can be added to patients' electronic health records and printed out or displayed on a computer screensaver, and other interventions that engaged patients and their families in strategies to prevent falls. The investigators found that their program, which focused on tools that engage patients and families in the fall prevention process throughout hospitalization, was associated with significantly reduced falls and fall-related injuries at three different hospitals. The team's results are now published in *JAMA Network Open*. [Read more](#).

CMMI Offers RSNAT Evaluation

The Centers for Medicare and Medicaid Services Innovation Center (CMMI) has released updated spending and affirmation rates from the first five years of the Prior Authorization Model for Repetitive, Scheduled Non-Emergent Ambulance Transport (RSNAT.) The RSNAT Prior Authorization model was successful in reducing RSNAT and total Medicare spending while maintaining overall quality of and access to care levels. Through the use of prior authorization, the model dramatically reduced both RSNAT service use and RSNAT expenditures, by 63% and 72%, respectively, resulting in a reduction of approximately \$550 million in RSNAT service expenditures and total Medicare savings of \$650 million for beneficiaries with ESRD and/or severe pressure ulcers. Overall, our quantitative analysis suggests no impact on observed quality and access as measured by emergency department visits, emergency ambulance use, unplanned inpatient admissions, and death. HHS Publishes New Rules to Intended to Improve Value Based Care

The Department of Health and Human Services (HHS) published two final rules that aim to reduce regulatory barriers to care coordination and accelerate the transformation of the healthcare system into one that pays for value and promotes the delivery of coordinated care. The rules provide greater flexibility for healthcare providers to participate in value-based arrangements and to provide coordinated care for patients. The final rules also ease unnecessary compliance burden for healthcare providers and other stakeholders across the industry, while maintaining strong safeguards to protect patients and programs from fraud and abuse. The HHS Office of Inspector General (OIG) issued the final rule "Revisions to the Safe Harbors Under the Anti-Kickback Statute and Civil Monetary Penalty Rules Regarding Beneficiary Inducements," and the Centers for Medicare and Medicaid Services (CMS) issued the final rule "Modernizing and Clarifying the Physician Self-Referral Regulations."

information that's on the original compare tools. It gives you, patients, and caregivers one user-friendly place to find cost, quality of care, service volume, and other CMS quality data to help make informed health care decisions. Now, instead of having to search through many compare tools, with just one click on Care Compare, you'll find easy-to-understand information about nursing homes, hospitals, doctors, and other health care providers. Please remember that when we retire the 8 original compare tools, you will still be able to find information about health care providers and CMS quality data on Care Compare, as well as download CMS publicly reported data from the [Provider Data Catalog](#) on CMS.gov. HHS Proposes Unprecedented Regulatory Reform through Retrospective Review

The Department of Health and Human Services recently issued a notice of proposed rulemaking requiring the Department to assess its regulations every ten years to determine whether they are subject to review under the Regulatory Flexibility Act (RFA), which requires regular review of certain significant regulations. If a given regulation is subject to the RFA, the Department must review the regulation every ten years to determine whether the regulation is still needed and whether it is having appropriate impacts. Regulations will expire if the Department does not assess and (if required) review them in a timely manner. Under the proposed rule, any regulation issued by HHS (with certain exceptions) will cease to be effective ten years after it is issued, unless HHS performs a plenary assessment of the regulation and a more detailed review of those regulations that have a significant economic impact upon a substantial number of small entities. The Center for Medicare and Medicaid Innovation’s (Innovation Center) Emergency Triage, Treat, and Transport (ET3) Model is a voluntary, five-year payment model that will provide greater flexibility to ambulance care teams to address emergency health care needs of Medicare beneficiaries following a 911 call. The National EMS Information Systems Technical Assistance Center (NEMSIS TAC) based at the University of Utah is working directly with NHTSA’s Office of EMS and the CMMI to assist states and EMS agencies implement the Model. The FirstNet mission is to deploy, operate, maintain, and improve the first high-speed, nationwide wireless broadband network dedicated to public safety. Before choosing or promoting a mobile device application to serve first responder needs, all applications listed in the FirstNet catalog have been scanned for malware and severe security vulnerabilities to better protect the public safety community. Certified apps have passed more stringent security assessment. If it is in the FirstNet Catalog, it is relevant to public safety and the unique needs of first responders. All apps listed in the catalog have been evaluated to ensure sensitive data or important enterprise info will not be compromised. APSA Offers New EBG on Post-op Opioid Use in Children

New guidelines by the American Pediatric Surgical Association (APSA) Outcomes and Evidence-Based Practice Committee aim to steer surgeons away from excess opioid prescribing in postoperative settings. The committee recommends providers first recognize the risk of misuse and abuse in pediatric populations and educate families on expectations and methods of pain management before surgery and postoperative disposal when opioids are prescribed. While excess pills in the house pose the risk of accidental ingestion for younger kids, older adolescents are at an increased risk for diversion and misuse, which has been linked to risky behavior in adulthood, including conversion to heroin use. Factors Associated with EMS Transport Decisions for Pediatric Patients After MVC

Using NEMSIS data, researchers found that pediatric patients were not transported after EMS responded to a motor vehicle collision in approximately one-third of cases (31,404 out of 92,254 identified), and there was considerable variation in the rate of non-transport based on geographic region, provider level, and time of day. The majority of non-transport occurred because patients were discharged against medical advice or the patient/caregiver refused transport, which may indicate conflicting priorities between EMS clinicians and patients.

Gender and Location Disparities in Bystander AED Usage

Utilizing NEMSIS data, researchers determined that male patients are 34% more likely to receive bystander automated external defibrillator (AED) usage compared to female patients. Researchers suggest that given bystander AED usage among males and females declined as cardiac arrest locations became more remote, improvements in rural and frontier AED availability and training are necessary to increase bystander AED usage rates in those regions.
