Funding Update - Rachael Alter

The NASEMSO team has prepared an unsolicited proposal for NHTSA. Waiting for a few additional items to fall into place before submitting. Andy noted that the Board is supportive of the need for funding through DOT; NASEMSO team will be meeting soon to discuss next steps. Consider support letters/mailing campaign regarding the funding; Andy will take this concept back to the NASEMSO funding team for potential further discussion with the Board.

Recommend the Committee review the recently released <u>National Roadway Safety</u> <u>Strategy</u>. In addition to post-crash care & the language regarding safe roadways & consumer protection could be of interest to this group.
