2014 FARB RLS a Great Success!

Nearly setting a record, 124 board members, administrators, executive directors, attorneys, investigators and staff attended the 22nd Annual FARB Regulatory Law Seminar in beautiful Annapolis, Maryland this October.

Maryland Attorney General Doug Gansler provided opening remarks and the speakers



were given high marks for quality sessions. Topics ranged from Immunity and Antitrust to Ethics and Social Media. Sunday sessions included an in-depth look at statutes and regulations and how to avoid common problems.

The conference kicked off on Thursday afternoon with a new optional session entitled "The ABC's of Regulatory Law." Designed to introduce newcomers to Professional Regulation and also to act as a refresher for old-timers, the session attracted 60 participants for a rousing discussion of the issues.
