- Incoming/Outgoing

- Bylaws Change
 - Morgan directed the group to the NASEMSO website to review the by-law changes.
 - Morgan said the Safe Transport of Children Ad-hoc committee will shift to a standing committee for NASEMSO if the Bylaws are approved this week.

- Mr. Wages thanked the council for their hard work.

- Mr. Vance gave an update on the PECC Collaborative. With 9 teams participating, it makes up about 10% of the country's EMS agencies. There are new resources available on the EIIC PECC Learning Collaborative website. There will be a collaborative meeting at the all grantee meeting in August in Washington, DC.

- Mr. Vance said the NPRP hospital toolkit is being updated. The next assessment will be in 2020. The Prehospital Peds Ready Toolkit guide will be available in summer of 2019. There is a new Prehospital Pediatric Readiness Steering Committee meeting. The Prehospital Peds Ready assessment will be 2021/2022 or 2024/2025.
- Mr. Vance described the Nomenclature of the EMS Profession. National EMS Advisory Council (NEMSAC) is offering recommendations to the Federal Interagency Committee on EMS (FICEMS) and the Department of Transportation (DOT). Some of the things discussed were using the word “paramedicine” to replace “emergency medical services”. A document will be redistributed for public comment later in 2019.
- Mr. Vance reminded the group that May 20-24 is EMS week and Wednesday, May 22 is recognized as EMS for Children Day. There will be a webinar on EMSC Day. Information can be found on the EIIC website.
- Mr. Vance also presented the idea of EMSC Day for nurses. This would take place during nurses week or on emergency nurses day. Discussion followed; and concerns arose of how to manage this concept and which groups of nurses to include.

State Highlight: South Carolina Opioid and Kids

- Dr. Alier presented the work South Carolina is doing to raise awareness of the opioid crisis for the pediatric population.

State Highlight: Louisiana and Human Trafficking

- Amanda Perry (LA) gave a presentation on the Adverse Childhood Experience (ACE) program study/score and how it relates to children’s healthcare outcomes.

HRSA Update

- Jocelyn Hulbert presented the update and gave an overview of the HRSA programs. She gave a brief overview of the EMSC performance measures, annual data collection, targeted issues, SPROC grants and PECARN.

NEDARC Annual Data Collection

- Mr. Ely spoke to the group about the new annual data collection beginning in 2020 and the changes to the performance measure assessments.
- Mr. Green gave an update about the new projects at NEDARC including, stakeholder groups, contact groups, email bounce backs and web based contact management systems.

Joint Session with Trauma Managers

- Utah Pediatric Trauma Network
 - Dr. Steven Fenton gave a presentation on the Utah Pediatric Trauma Network. The state department of Health and the state's only pediatric trauma hospital worked together to create a system to provide resources for the state's non-pediatric hospitals to care for pediatric trauma at their facility.
- South Carolina Pediatric Trauma Transport Protocol
 - Mr. Wisniewski presented the mandatory state Pediatric Trauma Transport Protocol. He explained the need for it in South Carolina and the way the protocol was developed.

State Highlight: High Performance CPR

- Cindy Wright-Johnson presented on the development and implementation of high performance CPR. She and stakeholders wrote a protocol, created training videos and workshops for high performance CPR. She provided resources and data collection from the project.

Pediatric Disaster Preparedness

- Sean Andrews with ASPR gave the group an update on the upcoming FOA on pediatric disaster preparedness.

- ASPR is standing up a Medical Countermeasures Operations Program to assist state and local partners with MCM distribution and dispensing operational planning and exercise evaluation.
- He said the National Pediatric Disaster Initiative comment period closed and a FOA for the two pilot projects should be out later this spring. Agenda 2050 Crosswalk Documents

- The council broke into 5 groups and focused on the main topics of the Agenda 2050 document. They were asked to focus on the pediatric components and how that could be related to the council. The topics included: Adaptable and Innovative, Inherently Safe and Effective, Sustainable and Efficient, Integrated and Seamless, Socially Equitable, Reliable and Prepared. The five groups then reported their work to the full council. Discussion followed.

- Morgan said that the steering committee decided that for the all grantee meeting in August, each state will need to update their state's one page fact sheet. The deadline to submit will be June 15, 2019.
