2. Kevin McGinnis Appointed to FirstNet Board

U.S. Commerce Secretary Rebecca Blank appointed twelve of the nation’s leading experts on public safety and wireless broadband communications to serve on the Board of the First Responder Network Authority (FirstNet), to include NASEMSO’s own, Kevin McGinnis. FirstNet is congressionally mandated to establish a nationwide wireless broadband network that enables police, firefighters, emergency services personnel, and others in public safety to better communicate with one another during emergencies and use new technology to improve response time, keep communities safe, and save lives. The FirstNet Board is tasked with deploying a nationwide, interoperable, public safety communications network as recommended by the 9/11 Commission in order to resolve communications challenges faced by emergency responders nationwide. By law, the FirstNet Board represents experts in public safety, technology, network operations, and finance. The Act also requires the Board’s inclusion of at least three public safety professionals and at least three members representing the interests of States, localities, tribes, and territories. The Association of State and Territorial Health Offices (ASTHO) has developed a series of toolkits that address the key information needs of public health officials in understanding and using legal authorities to prepare for and respond to public health emergencies. This series arose from needs identified by state and local public health agencies regarding certain legal questions and uncertainties that were perceived to be barriers to effective planning and response to infectious disease outbreaks, natural disasters, intentional acts, and other emergency events. 7. New Emergency Response and Counter Terrorism Collection

Recent acts of terrorism and natural disasters have devastated many of our communities, raising an increased awareness of the importance of emergency preparedness. When unexpected events occur, it is important that our first responders are prepared to deal effectively with emergencies of all kinds. To help prepare our first responders for emergencies, particularly those involving hazardous materials, the U.S. Government Printing Office has assembled a new collection of publications focusing on emergency response and counterterrorism.

8. New Health Monitoring and Surveillance Tool for First Responder

This month the National Institute for Occupational Safety and Health (NIOSH) released the [Emergency Responder Health Monitoring and Surveillance](#) (ERHMS) system to address the concerns of assessing responders' health after they have completed their deployment. According to NIOSH, "While some guidance had been developed about how best to prepare response workers both before and during deployment, less attention had been placed on assessing responders' health after they complete their deployment. The ERHMS system includes both written guidance and epidemiology/surveillance tools as examples of current best practices for protecting response, remediation, and recovery workers and volunteers. The system can be applied in both smaller, localized incidents, as well as larger incidents. Importantly, it provides guidance to help protect emergency responders before, during, and after an incident.

9. Free Training Offered for First Responder Safety at a Small Aircraft or Helicopter Accident

As small aircraft and helicopters have become more complex, technology has provided systems that have enhanced operational safety. In the event of an accident, many of these systems have presented additional hazards to first responders or any potential rescuer at an aircraft accident scene. The FAA, in cooperation with General Aviation Manufacturers Association (GAMA), various manufacturers and first responder professional organizations, has developed training for safety at an aircraft accident scene. While the material was initially developed for firefighters, EMS and police, it provides useful information for any persons that may come across an aircraft accident. 10. BTS Releases State Transportation Statistics 2011

The U.S. Department of Transportation's Bureau of Transportation Statistics (BTS), a part of the Research and Innovative Technology Administration (RITA), released its annual *State Transportation Statistics 2011 (STS)* – a web-only reference guide to transportation data for the 50 states and the District of Columbia. STS 2011 includes a wide range of state-by-state information, such as the calculations showing which states had the highest and lowest number of highway traffic fatalities per 100,000 population in 2010. The ninth annual STS consists of 115 tables of state data on infrastructure, safety, freight transportation, passenger travel, registered vehicles and vehicle-miles traveled, economy and finance, and energy and environment, plus a U.S. Fast Facts page. 11. States Debate Who Should Make "Return to Play" Decisions for Youth Athletes

Stateline reports that while several states have passed anti-concussion legislation over the past several years, legislators in certain jurisdictions have recently faced unexpected opposition to similar proposals. Many of the existing laws focus on who can make "return to play" decisions for youth athletes who suffer head injuries during a game. In some states, however, lawmakers and health care professionals have debated who is most qualified to make these decisions – the most knowledgeable health care providers are not always the most accessible within a community. 12. Leading Physician & Medication Safety Groups Endorse ENA Position: Weigh Pediatric Patients in Kilograms

The American College of Emergency Physicians, the American Academy of Pediatrics, and the Institute for Safe Medication Practices have all endorsed the Emergency Nurses Association's (ENA) position statement [Weighing Pediatric Patients in Kilograms](#). The statement recommends several practices to ensure that pediatric patients' weights are consistently measured and recorded in kilograms, including:

- Scales used to weigh pediatric patients only be configured to record weights in kilograms.
- Pediatric weights are recorded in a prominent place on the medical record.
- Electronic medical records are standardized to allow only kilograms for pediatric weight entries.
- The pediatric patient's actual weight is considered part of the mandatory nursing assessment unless they require resuscitation or emergent stabilization.
- For the pediatric patient who requires resuscitation or emergent stabilization, a standard method of estimating weight in kilograms is used (e.g., length-based system).
- The pediatric patient's weight in kilograms is included in any inter- or intra-disciplinary patient hand off report.

13. Save the Children Releases Annual Disaster Report

Save the Children recently released its fifth annual National Report Card on Protecting Children During Disasters. The report analyses four basic disaster preparedness and safety standards for children. To meet benchmarks, “states must require all regulated childcare settings to have written plans for evacuation and relocation, for family reunification following an emergency, as well as a specific plan to assist children with disabilities and those children with access and functional needs.” For a copy of the [report](#).

17. CDC Releases Older Adult Preparedness Portal

The Centers for Disease Control and Prevention released "Identifying Vulnerable Older Adults and Legal Options for Increasing Their Protection During All-Hazards Emergencies: A Cross-Sector Guide for States and Communities," along with a preparedness Web portal. The guide focuses on topics such as developing plans, building registries,

partnering and collaboration, and more. 18. HHS Has Taken Steps to Address Unsafe Injection Practices, but More Action Is Needed

Data on the extent and cost of blood-borne pathogen outbreaks related to unsafe injection practices in ambulatory care settings are limited and likely underestimate the full extent of such outbreaks. An agency within the Department of Health and Human Services (HHS), the Centers for Disease Control and Prevention (CDC), collects data on outbreaks identified by state and local health departments. These data show that from 2001 through 2011, there were at least 18 outbreaks of viral hepatitis associated with unsafe injection practices in ambulatory settings, such as physician offices or ambulatory surgical centers (ASC). CDC officials and others believe that the known outbreaks do not represent the full extent of such outbreaks for a number of reasons, such as infections often being difficult to detect and trace to specific health care facilities. Additionally, comprehensive data on the cost of blood-borne pathogen outbreaks to the health care system do not exist, but CDC and other officials believe these costs can be substantial for those affected. 21. NIOSH and OSHA Evaluate Deepwater Horizon Oil Spill Cleanup

22. AHRQ Releases Training Modules to Help Improve the Safety of Nursing Home

The Agency for Healthcare Research and Quality (AHRQ) has released a set of training modules to help educate nursing home staff on key patient safety concepts critical to improving the safety of nursing home residents. The modules, Improving Patient Safety in Long-Term Care Facilities include the following publications:

- Detecting Change in a Resident’s Condition
- Communicating Change in a Resident’s Condition
- Falls Prevention and Management

Each of the modules has an instructor’s guide and a student workbook. Training of nursing home staff, including support for teamwork across specialties, is likely to be effective in reducing medical errors and improving patient safety and can help reduce the number of falls and fall-related injuries at nursing centers. 24. GSA freezes per diem rates for 2013

The General Services Administration will freeze per diem rates at current levels for 2013, with only a few exceptions. Freezing the reimbursement rates for lodging, meals and incidentals will avoid an estimated \$20 million in costs in 2013 and help agencies meet the Obama administration’s directives to reduce travel costs government-wide, GSA said in a news release last week. 25. CDC Expanded Hepatitis C Testing Recommendations

CDC now recommends that all U.S. baby boomers get a one-time test for the hepatitis C virus. Data show that 1 in 30 baby boomers has been infected with hepatitis C and this population is five times more likely than other adult Americans to be infected with the virus. In addition, more than 15,000 Americans, most of them baby boomers, die of hepatitis C-related illness each year. 26. Self- and Peer-Assessments of Ambulance Drivers' Driving Performance

The aim of the present study was to develop and examine the quality of the Ambulance Driver Self-assessment Questionnaire (ADSQ) and the Ambulance Driver Peer-assessment Questionnaire (ADPQ) measuring aspects of, driving performance, driving style and driving competence. In addition the ADSQ measures self-reflection and safety-attitudes. The aim of the study was also to examine ambulance drivers' self- and peer-assessments as well as to examine the accuracy of self-assessments by comparing self-assessed and peer-assessed driving performance, driving style and competence. 76 ambulance drivers employed at two ambulance stations in northern Sweden completed ADSQ and ADPQ. Item analyses were conducted to examine the psychometric properties of the items, and based on the results some revisions were made to improve the questionnaires. The revised questionnaires were functioning rather well, although some subscale demonstrated low internal consistency. Subscale inter-correlations provided support for construct validity. Self- and peer-assessments indicated safe driving performance and good driver competence, which is positive from a traffic safety perspective. A comparison of mean self- and peer-assessment ratings, controlling for age, gender and driving experience showed no significant differences, except for the subscale overtaking. This indicates that ambulance drivers' self-assessments are realistic in most areas. [For more information...](#)

 Ambulance crashes account for 74% of the fatalities in EMS. The injury rate in these crashes is seven times the national average, making ambulances a very dangerous environment to work in. In a case study of two very serious ambulance crashes, you will be able to recognize the events that led to these crashes. A case study will also focus on how an EMS service recovered from a fatal crash by adding Road Safety to its fleet. But in order to fully benefit from this technology, a high performing safety program must be deployed. You will learn how to do a self audit of your driver safety program, developing a program, key metrics to measure, training, culture shifts, crash investigation and staff rewards/recognition. 28. Presentations and Outcomes of Children With Intraventricular Hemorrhages After Blunt Head Trauma
Archives of Pediatrics and Adolescent Medicine recently published an [article](#) using data from a Pediatric Emergency Care Applied Research Network (PECARN) [study](#) to describe clinical presentations and outcomes of children with intraventricular hemorrhages (IVHs) after blunt head trauma (BHT). The *Archives* study took place within 25 emergency departments participating in PECARN from June 1, 2004 through September 31, 2006. The study included children younger than 18 years of age (n = 43, 398) presenting with IVH after BHT. The primary outcome of interest was an acute adverse event defined as death from traumatic brain injury, neurosurgical intervention, or intubation for greater than 24 hours of management of the head injury. The study concluded children with nonisolated IVHs after BHT typically present with GCS scores of less than 14, frequently require neurosurgery, and have high mortality rates. In contrast, those with isolated IVHs typically present with normal mental status and are at low risk for acute adverse events and poor outcomes.
