### **NASEMSO Leadership Discusses Pivot to Virtual Meeting**

In light of the prolonged national emergency, the futility of attempting an in-person annual meeting in Reno this year has been acknowledged and discussions are currently underway on whether to pivot to a series of virtual sessions. No further registrations for the 2020 annual meeting are being accepted and options for refunds and credits are currently being established. As we pause to determine a path forward to meet the association's needs, we continue to pray for the health and safety of our EMS responders, members, and partners. ### **NASEMSO Releases Statewide Specialty Systems of Care Assessment**

"Specialty Systems of Care: An Analysis of Statewide Practices Related to Time Sensitive Emergencies" is a new compilation from the National Association of State EMS Officials (NASEMSO) that focuses on the legal authority of states to organize and implement specialized systems of care for time sensitive emergencies such as stroke and chest pain. These elements are important to the matching of EMS and medical resources to patient needs and outcomes over a specified geographic area. The data was compiled from multiple interactions with state EMS officials, affiliated partners, and independent research to fill in several informational gaps from all 50 states and the District of Columbia. ### **McGinnis Named to PSAC Executive Committee**

NASEMSO Program Manager Kevin McGinnis has been named to the Executive Committee of the FirstNet Authority's Public Safety Safety Advisory Committee (PSAC.) FirstNet was required to establish a PSAC Consistent with the Middle Class Tax Relief and Job Creation Act of 2012. The PSAC offers FirstNet guidance, information, and subject matter expertise from a public safety perspective to ensure that user needs, requirements, and public safety operational capabilities are included in the network; provides subject matter expertise on concepts (e.g., policies, procedures, technologies, operational methods developed by FirstNet, and; advises FirstNet through the creation of initial documents, plans, or reports related to the build-out, deployment, and operation of a nationwide public safety broadband network (NPSBN). The PSAC reports include subject matter related to shared intergovernmental responsibilities or administration. Congratulations, Kevin!

### NG911 Roadmap: Making NG911 Happen at Nationwide Task

[NG911 Roadmap: Pathways Toward Nationwide Interconnection of 911 Services](#), identifies what needs to be accomplished at the national level – by all members of the 911 community – to make the full migration to NG911. The goals identified in this Roadmap are expected to be achieved through efforts undertaken by the spectrum of stakeholders that comprise the 911 community. Specifically, the Roadmap identifies potential tasks in support of the following areas: Business/Governance, Technology, Data, Operations, and Cross-Cutting.

### How States are Expanding Broadband Access

Broadband is increasingly intertwined with the daily functions of modern life. It is transforming agriculture, supporting economic development initiatives, and is a critical piece of efforts to improve health care and modernize transportation. But the Federal

Communications Commission (FCC) estimates that 21 million Americans still lack broadband access. Other sources place this number as high as 162 million. The Pew Charitable Trusts examined state broadband programs nationwide and found that they have many similarities but also differences that reflect the political environment, the state's resource levels, the geography of the areas that remain unserved by broadband, and the entities that provide service. ## NEMSIS 2019 Public-Dataset Now Available

The National Emergency Medical Services Information System Technical Assistance Center (NEMSIS TAC) today announced the availability of the 2019 Public-Release Research Dataset, the largest dataset of emergency medical service activations in the United States. With this release, NEMSIS aims to improve understanding of, confidence in, and support for EMS data collection and analysis that will lead to that data being utilized more effectively to improve patient care. The 2019 Public-Release Research Dataset is a subset of the national database that is used to store EMS data from the U.S. States and Territories. NEMSIS is a universal standard for how patient care information resulting from an emergency 9-1-1 call for assistance is collected. The dataset includes 34,203,087 EMS activations submitted by 10,062 EMS agencies servicing 47 states and territories. For more information, go [here](#).

## FBI Reports Active Shooter Incidents in the US in 2019

The FBI has designated 28 shootings in 2019 as active shooter incidents. The FBI defines an active shooter as one or more individuals actively engaged in killing or attempting to kill people in a populated area. This report is the fifth in a series of active shooter-related products published since September 2014. These reports are not intended to explore all facets of active shooter incidents. They serve to provide federal, state, tribal, and campus law enforcement – as well as first responders, corporations, and the general public – with a baseline understanding of active shooter incidents. ## Smoke-Ready Toolbox for Wildfires

Smoke from wildfires in the United States is adversely affecting air quality and potentially putting more people at health risk from smoke exposure. EPA, the U.S. Forest Service (USFS) and other federal, state and community agencies and organizations are working together to identify ways the public can prepare to reduce their health risk before a wildfire. Public health officials and others can use the resources in the Smoke-Ready Toolbox to help educate people about the risks of smoke exposure and actions they can take to protect their health. ## White House Announces Overhaul of Strategic National Stockpile

The President has [announced plans](#) to expand and restructure the Strategic National Stockpile. The White House said it plans to expand domestic production of supplies and equipment and utilize technology to improve visibility of supply chains.

Separately, President Trump signed an [executive order](#) assigning authority under the Defense Production Act to the U.S. International Development Finance Corporation, headed by former Center for Medicare and Medicaid Innovation Director Adam Boehler, to provide financing to key industries producing goods and services needed to increase national stockpiles.

### **FDA Targets Unauthorized Flavored E-cigarette Products to Youth**

The U.S. Food and Drug Administration recently issued ten warning letters to retailers and manufacturers who sell, manufacture and/or import unauthorized electronic nicotine delivery system (ENDS) products targeted to youth or likely to promote use by youth. The warning letters were sent to establishments marketing unauthorized products, such as a backpack and sweatshirt designed with stealth pockets to hold and conceal an e-cigarette, ENDS products that resemble smartwatches,

or devices appearing as children's toys such as a portable video game system or fidget spinner. Warning letters were also issued to companies marketing e-liquids that imitate packaging for food products that often are marketed and appeal to youth, such as candy, or feature cartoon characters like Sponge-Bob Square Pants. In 2018, the U.S. suicide rate was 14.2 per 100,000 standard population, with rates varying by state. The five states with the highest age-adjusted suicide rates were Wyoming (25.2), New Mexico (25.0), Montana (24.9), Alaska (24.6), and Idaho (23.9). The five jurisdictions with the lowest suicide rates were the District of Columbia (7.5), New Jersey (8.3), New York (8.3), Rhode Island (9.5), and Massachusetts (9.9).

### **CME America Class I Recall BodyGuard® Infusion Pump System**

CME America is recalling the BodyGuard® Infusion Pump Systems because the pumps may have a slower than expected delivery of medication (under-infusion), and faster than expected delivery of medication (over-infusion). The reason for the infusion errors is not known. The use of the affected infusion pumps may cause serious adverse health consequences including death. There have been 158 complaints regarding this device issue although to date, there have been no injuries or deaths. The recall includes the popular CME BodyGuard® 121 Pump that has become increasingly popular with EMS and air medical transport due to its small size. The company has issued an updated customer letter (April 27, 2020) with additional guidance and to inform customers of the decision to suspend distribution of the BodyGuard® infusion pump system and to remove CME America BodyGuard® infusion pumps from U.S. market. ### **Congressman Introduces Bill to Compensate High Risk by Essential Workers**

U.S. Representative Matt Cartwright (PA-08) has unveiled the “Coronavirus Frontline Workers Fair Pay Act”, a proposal to provide hazard pay to health care professionals and other essential workers. The bill compensates workers for the risks they are taking and for the public services they are providing during this unprecedented public health and economic emergency. Under Cartwright's proposal, high-risk health care workers receive a hazard pay increase of \$18.50 per hour, and other essential workers receive an increase of \$13 per hour. Pay would be capped at \$35,000 and \$25,000, respectively. It would be retroactive to January 31, 2020 and would be available through the end of this year. Read more [here](#).

### **New Ventilator Training Alliance Provides Free Educational Resources**

In an unprecedented move, ventilator equipment manufacturers worldwide have joined forces to create a free app to educate and assist licensed healthcare practitioners that are authorized to operate mechanical ventilators. The central knowledge hub provides free mobile access to video tutorials, instruction manuals, and other training materials for a full range of equipment

that is critical to helping clinicians treat patients suffering from respiratory distress. The need was identified as a result of the global pandemic and the rapid exchange of ventilatory equipment but is expected to serve an ongoing need. NASEMSO reminds EMS personnel of the need for proper education, credentialing, and authorization by their EMS medical director and/or state EMS authority related to airway management and the operation of mechanical ventilators prior to use. We also remind EMS practitioners that in the event of loss or inadequate operation of the ventilator for any reason (malfunction, lack of experience/confusion of the operator), the patient should be immediately be ventilated with a bag valve mask with a HEPA filter in place until the issue has been successfully resolved. ### **Peanut Allergy: New Advances and Ongoing Controversies**

Peanut allergy is one of the most common food allergies in children, with increasing prevalence over time. The dual-allergen exposure hypothesis now supports transcutaneous sensitization to peanut as a likely pathophysiologic mechanism for peanut allergy development. As a result, there is emerging evidence that early peanut introduction has a role in peanut allergy prevention. Current first-line diagnostic tests for peanut allergy have limited specificity, which may be enhanced with emerging tools such as component-resolved diagnostics. **Although management of peanut allergy includes avoidance and carrying an epinephrine autoinjector, risk of fatal anaphylaxis is extremely low, and there is minimal risk related to cutaneous or inhalational exposure.** Quality of life in children with peanut allergy requires significant focus. Moving forward, oral and epicutaneous immunotherapy are emerging and exciting tools that may have a role to play in desensitization to peanut. Subscription required to read full article [here](#).
